## BUSKING PA PERMIT AGREEMENT

By completing the below, I agree to the following terms in relation to applying for a PA Permit specific for the use of busking at the following locations as stated by Guernsey Arts and the St Peter Port Constables:

- By the Liberation Monument
- La Plaiderie, opposite JB Parkers
- To the side of Next
- La Marchant Steps; half way up Smith Street
- High Street, outside Boots
- Outside Guernsey Information Centre
- Between Fletcher Sports & Dix Neuf
- Bottom of Market Steps
- Town Church
- Town Church; seaward side
- Bus terminus; outside Picquet House
- Market Square (by arrangement of Bailiwick Estates)
- Mill Street
- The Golden Lion
- The High Street, outside Creasey's

I confirm that I have applied for and received confirmation of approval of a busking permit through Guernsey Arts, as issued by the Constables of St Peter Port.

I agree that where I receive complaints directly or where I am requested by an officer of the Office of Environmental Health and Pollution Regulation (OEHPR), or by representatives from Guernsey Arts or St Peter Port Constables, I will reduce the volume of my PA or amplifier.

I agree that a PA will be used only within the hours of 5pm to 7pm outside Boots Monday to Fridays, and 10am to 7pm Saturdays. All other locations a PA will be used only 10am to 7pm, Monday to Saturday. Performances will be no longer than 1 hour at any given location as per the busking guidelines.

I understand that my details may be used by OEHPR, St Peter Port Constables and Guernsey Arts in order to contact me about changes to locations, changes to the Busking PA Agreement, any other relevant changes or complaints.
